Investment strategy

- Altaroc Global Evergreen is an evergreen fund **100% invested in Private Equity**, with a predominant focus on **Buy-Out** and **Growth** underlying strategies. Its core **secondary investment strategy** is executed through secondary mandates alongside leading international managers with long-standing track records, across both **LP-led and GP-led transactions**.
- Its geographical exposure is global with a primary focus on **North America** and **Western Europe** and it offers deep diversification through thousands of underlying portfolio companies.

Q2 Commentary

Market environment

- Following a record year in 2025**, during which the global secondary market reached an **all-time high of \$240bn in transaction volume**, activity has remained particularly strong in early 2026. This growth has been driven by persistent liquidity needs from both institutional investors (LPs) and private equity sponsors (GPs), with **GP-led transactions now accounting for nearly half of total market volume**. Continuation vehicles have become an increasingly important portfolio management and liquidity tool, further reinforcing their central role within the private equity ecosystem.
- Early indicators suggest that 2026 could be another year of strong activity for the secondary market. According to Pathway, **transaction backlogs alone are expected to generate more than \$100bn of volume during the first half of the year**, providing strong visibility on future deal flow. This momentum is supported by favorable market fundamentals, including a growing and increasingly diversified buyer universe, substantial levels of available dry powder, and **rising strategic allocations to secondary strategies**.
- More broadly, the private equity environment continues to create supportive conditions for secondary market growth. Distributions remain below historical averages, exit markets are still selective, and fundraising conditions remain challenging across many segments of the market. As a result, **demand for liquidity solutions continues to increase among both investors and fund managers**.

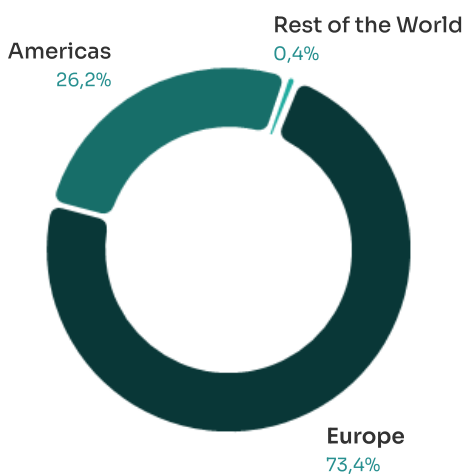

Performance

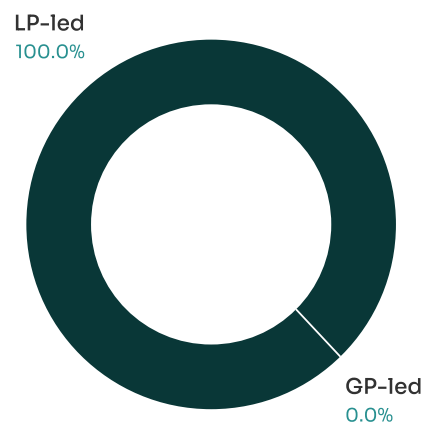
- Over the end of March and beginning of April, Altaroc Global Evergreen completed the closing of its initial investments through **three LP-led secondary transactions, marking the effective deployment of the portfolio.**
- These first transactions provide **exposure to a total of 10 underlying funds managed by 7 leading general partners**, giving access to a broad base of **more than 100 underlying companies**, including approximately 25 core positions of particular significance. The portfolio is predominantly oriented towards **middle-market buyout strategies**, in line with the fund's investment objectives.
- The portfolio is primarily **exposed to Europe (c. 2/3) and North America (c. 1/3)**, and benefits from **strong vintage diversification**, with main exposures to the 2014 to 2019 vintages.
- These first investments contributed to an approximately **+13% revaluation in the initial NAV** and have already generated distributions of around 5% of the invested amounts, which will be reinvested into new transactions alongside additional capital raised over April.
- Further investments are expected to be completed by the end of Q2, with one transaction already secured.

Breakdown by geography



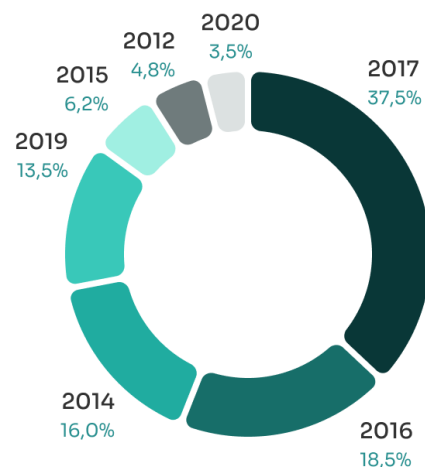
Breakdown by investment strategy



Breakdown by deal type

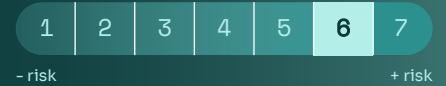


Breakdown by maturity

Subscription Terms	Subscriptions are made by Eligible Investors only, through the execution of a Subscription Agreement. Glossary

Amount allocated

The capital that has been allocated to underlying funds.

Amount invested

The amount invested by the fund via funds and co-investments.

Capital call

A capital call is a request for subscribers to pay all or part of the capital they have committed to subscribe to the fund. The call will be used to finance the acquisition of target companies and the fund's expenses. In the case of Altaroc, as the capital calls on the Vintages are staggered, subscribers pay the capital – up to the limit of the commitment made at the time of subscription – in several successive capital calls.

Build-up

A build-up is an external growth strategy based on the acquisition of companies in the same sector (often competitors), with the aim of creating industrial synergies.

Buy-Out

This represents by far the largest proportion of Private Equity and comes into play at the time of the sale or Buyout of a company.

This type of investment transaction is often financed by debt, i.e. leveraged. In this case it is known as a leveraged Buyout (LBO).

Carried interest

Performance-based incentive for management company teams calculated on the basis of the income and capital gains of a private equity fund (generally 20%).

Co-investment

Refers to a minority interest in a company that an investor acquires alongside a fund. A fund may need to offer co-investments to top up the funds it invests (transactions that exceed its maximum investment ticket per transaction) or to comply with its investment ratios (maximum percentage of a company's capital held). For investors, management and subscription fees are in most cases lower than those charged for transactions via funds.

DPI (Dividend To Paid-in)

Total distributions paid to investors as a ratio of the total amount called.

EBITDA (Earnings before Interest, Tax, Depreciation and Amortization)

An internationally recognised financial indicator that measures the cash flows generated by a company's operating cycle.

ESG

Environment, Social, Governance. An ESG approach is one that takes into account environmental, social and governance issues.

Fair Market Value

Fair market value is an accounting standard that values assets and liabilities based on an estimate of their market value.

FinTech

FinTech, a shortened form of Financial Technology, refers to small companies (start-ups and SMEs) that provide financial services using innovative solutions. It is used in a wide range of applications: mobile payments, crowdfunding, savings management, online financial advice, etc.

GPR (Gross Portfolio Return)

A measurement of portfolio performance taking into account investment and disposal flows and the timing of these flows.

Growth Capital

The fund acquires an interest in a company that has been in existence for a number of years and is profitable or close to breaking even. The cash invested is used to consolidate the company's financial structure with the aim of moving on to a new phase of growth.

IRR (Internal Rate of Return)

Refers to the average Internal Rate of Return (IRR) calculated over the life of the investment portfolio. IRR measures the performance of an investment taking into account cash inflows and outflows, as well as the timing of these cash flows.

LBO (Leveraged Buy-out)

A financial transaction in which a company is acquired using mainly debt. The target company's cash flows, increased by improved management, are used to repay the loan required for the investment. Once the investment has reached maturity, the fund can sell the company or take part in its IPO.

Net Asset Value (NAV)

Represents the total value of the fund's assets less its liabilities. It is therefore calculated by adding the portfolio at fair market value, plus the fund's cash and liabilities (including carried interest debt).

The change in NAV over a given period comes from the value created by the portfolio over the period, less all expenses and the allocation to the provision for carried interest.

Private Equity

Private Equity involves supporting the development and/or improving the performance of unlisted companies by acquiring significant stakes in their capital.

LP-Led transactions

Traditional secondary transactions involving the acquisition of limited partner interests in existing private equity funds. Their main advantage lies in the high level of diversification they provide. A secondary transaction typically involves a portfolio of multiple funds, each of which is itself invested in a large number of underlying companies, offering investors immediate and broad exposure to the asset class.

GP-Led transactions

Transactions initiated by general partners, involving the acquisition of portfolios composed of one or several residual assets (GP-led single-asset or multi-asset transactions).

GP-led transactions offer the advantage of providing exposure to more mature, well-established companies that are already known to the sponsor.

TVPI (Total Value to Paid-In)

The sum of the value of the portfolio and the distributions made by the fund, divided by the total amount paid in by the subscriber. If it is greater than 1, the fund is in a position of capital gains.
